Co-op members who have a smart phone or tablet should download SWRE's app!

SWRE's smartphone app is available free for Apple devices (at the iTunes App Store) or Android devices (at the Android app store).

At the online stores, search for "Southwest Rural Electric" to find and download the free app.

Members who already have an online bill-pay account can use their username and password to log in. Members who don't have an existing log-in can create one. To create a bill-pay account, the member's social

Reporting an outage via app is easy. security number and current phone number must be on file with SWRE.

Members can then use the app to pay their SWRE bill, set up bill-pay reminders and notifications, update telephone numbers, or monitor usage all from their smart phone or tablet!

They can also report outages directly from the app! This feature is especially helpful in widespread outages when the

Now power is out! A new very valuable feature of the app is an SWRE outage map. It can be opened by touching the "Outage Map" icon at bottom right of the app screen. The outage map shows general location and numbers of all known or projected outages that

exist in each county of SWRE's service territory.

# **Co-op deals with challenges and opportunities**

The year since our last annual meeting has been an interesting one! The tornados of May 2015 were followed by decreased electricity usage by members due to a moderate summer and downward spiral of the oil fields and economy. Those factors precipitated less-than-normal margins for the cooperative, but the SWRE Board still approved payment of capital credits to our members.

### **Storms Wreaked Havoc**

Unfortunately, "Old Man Weather" was not very cordial as SWRE experienced two ice storms as the year wound down. An early ice storm during Thanksgiving weekend caused several days of outages, but possibly the worst ice storm in our co-op's history blew through the day after Christmas. Ice accumulations and storm gusts for three straight days resulted in damage over the entire SWRE service area – no area was spared! Western Farmers (our wholesale power provider) also lost transmission to every substation, as well as backup feeds from PSO/AEP.

As damage estimates were evaluated each day, the damages doubled the second day, and the final night of 70 mph winds caused as much damage as the first two days combined. The last residence outage was restored in thirteen days, but work continued for several months. The spring rains, floods, windstorms, and the multitude of never-ending lightning storms also caused new problems as well as exposing damage that may not have been apparent during the ice storms.

SWRE has filed for FEMA in both states and we hope to recover a portion of those storm costs.

#### **Technology Improvements**

There were also some very exciting things that happened during the last year! Most of the technology infrastructure that SWRE has been building over the last ten years has resulted in the debut of valuable tools for both our members and cooperative. Members can download our SWRE app and look at their usage, establish alerts like bill pay reminders or a text message when your bill approaches a certain dollar threshold, or even report an outage without calling in. Usage can also be viewed on the SWRE website. Our staff will be available at the annual meeting to help members download the app, or members may call our office anytime for help over the phone. Members can also see the outages in our service area on the app or can go to the statewide site at oaec.coop and see outages for co-ops all over Oklahoma.

Our linemen now have iPads with maps and outage information to better identify where the problems are occurring. Much of our new technology requires the merging of data from numerous servers that we have been building for years. That data can be sent back centrally to our "war room" during major storms that will give us a total view of the entire situation and allow us to make quicker responses than before. Technology, however, can never replace the dedication that our men and women have demonstrated during those large storms.

### **January Retirement**

This 2016 annual meeting will be my last one as CEO/General Manager of SWRE. I had already planned to retire in January of 2017, but a heart attack in late May (and a new stent) solidified that decision. The Board is presently conducting a search for the next CEO, and my replacement should be on the job sometime in December.

I live on SWRE's lines, so next year I'll attend the annual meeting as a member – and possibly win one of those prizes! As SWRE approaches a time of transition, our staff and employees will continue to provide electricity through our vision of "safety, service and satisfaction – one member at a time." Thank you for letting us serve you!

# **Community solar coming to SWRE**

Do you want to utilize solar energy at your home or business, but avoid the expense of installation and maintenance of unsightly solar panels on your property?

SWRE may have the solution for you. The co-op is planning construction of two community solar fields – a 250 kW field in the Frederick area and a 100 kW field south of Vernon.

Any SWRE members who opt to participate may purchase a "share" in the fields equivalent to one solar panel, and lock in a guaranteed rate for the next 25 years (through 2041).

Shares cost \$350 each, payable at the time of purchase. A total of 1,368 shares are available – 950 in the Frederick field and 418 in the Vernon field. Shares may be purchased in quantities ranging from 1 to 25. Any SWRE member, at any location in the co-op's service territory, may participate.

After the share purchase, members will be credited on their monthly SWRE bill based on their portion of the fields' production. Participants will not own any of the panels or infrastructure.

At current power rates, it is estimated that the payback period for members who choose to buy shares is approximately 15 years.

The solar fields are being constructed on tracts of



land that are owned by SWRE – one mile south of Frederick on HWY 183 (at Airport Road), and south of Vernon on Center Drive adjacent to Madison Crossing Apartments.

The solar fields will be built in stages in coming months. They are expected to be operational by December or January.
