

## Simmons named as SWRE CEO

Kenneth E. Simmons has been named as the new CEO of Southwest Rural Electric Cooperative. He replaces longtime CEO Mike Hagy who will retire in early January.

Simmons is a 35-year veteran of the electric co-op industry. He comes to SWRE from Carroll Electric Membership Cooperative in Carrollton, Georgia, where he served as Manager of System Design.

Prior to joining Carroll EMC in 2011, Simmons was president/CEO of Utility Design Services, Inc., a utility consulting firm in Atlanta, Georgia. In that capacity Simmons worked with dozens of electric distribution cooperatives of all sizes across the Southern United States.

Simmons and his wife Kim are both natives of Baton Rouge, Louisiana.

## SWRE CEO Report

CEO Mike Hagy will retire from SWRE effective January 3, 2017

### What I will miss... and what I won't

As I compose my final **SWRE News** article prior to retirement, bittersweet emotions come to mind.

My ten-plus years as a director and 11 years as the CEO/general manager evoke some memorable moments. In reality some of those times were better memories than others. As I look back, there are things that I will not miss and there are other things that I definitely will miss!

I won't miss ice storms.

The Christmas Eve storm of 2009 was the year that all of our employees missed Christmas and most of the week after. That same winter on January 28, 2010, we were hit again and lost approximately 3,500 poles, mostly in the northern area of our service area.

Last year at Thanksgiving 2015 we lost about 700 poles to ice, which was followed on December 26-28 by what was possibly our worst ice storm ever. During that storm the damage increased day by day over our entire service area. Western Farmers could not provide transmission power to any sub-stations and SWRE again had lost approximately 3,000 poles.

I won't miss the tornados, windstorms, and lightning storms.

We experienced four major tornados in two years, several windstorms with hurricane force winds, and so many severe lightning storms that I have lost count. Also, you can throw in some wild fires during our severe drought and major flooding during our last two springs.

I also won't miss the anxiety of watching the radar and outage maps as severe weather approaches. During my heart attack episode and hospital stay, my wife actually hid my phone and iPad so that I couldn't look at storms and outage maps.

I won't miss the monthly road trips to Austin, Abilene, Oklahoma City, Anadarko and various other cities around the US. It's important that the CEO attend all those meetings to represent SWRE's interests, but the travel is often time-consuming and difficult.

Those are all things that I will not miss in retirement.

What WILL I miss?

I will miss the great SWRE employees, both active and retired, who I have had the great fortune to work with over the years.

I will miss the relationship with SWRE's directors that I have en-

joyed as both a fellow director and manager.

I will miss my extended cooperative family made up of the personnel from co-ops throughout Texas and Oklahoma. I will also miss the people and support from both Texas and Oklahoma statewide organizations – the Oklahoma Association of Electric Cooperatives and Texas Electric Cooperatives.

I will miss the challenges associated with a small cooperative competing in a large market in a new era of power.

And... I will miss the members of SWRE. There have been times of criticism and times of praise, but our members are consistently the best members a cooperative could hope for.

As I look back, there are still many things to accomplish and there will always be new challenges.

It is my hope that in some small way I have helped to move our cooperative along the road of progress while seizing the opportunity to share the vision of safety, service, and satisfaction – one member at a time!

## SWRE to pay patronage capital

The SWRE Board of Trustees has approved \$250,000 in patronage capital payments to members of the co-op.

The payments are based on energy purchased during parts of 1976 and 2015 and will be paid according to kilowatt hours of electricity used during parts of those specific years.

SWRE is a cooperative, so each member-owner has a share in money that is left over after all operating costs are paid. This money is called margin.

A member's share of the margin is called capital credit or patronage capital,

and is determined by how much electricity was purchased. The more purchased, the bigger the share.

The members are allocated their share of margins each year. That share is paid when SWRE is financially able.

The patronage capital checks will be mailed in December.

The combination method of paying from multiple years means that most SWRE members will receive a check in December. No check will be issued for any amount less than \$5.

## What's Cookin' in the SWRE Kitchen

### Pecan Squares

#### Crust

- 1-1/4 lb. unsalted butter, room temp.
- 3/4 cup granulated sugar
- 3 extra-large eggs
- 3/4 teaspoon pure vanilla extract
- 4-1/2 cups all-purpose flour
- 1/2 teaspoon baking powder
- 1/4 teaspoon salt

#### Topping

- 1 lb. unsalted butter
- 1 cup good honey
- 3 cups light brown sugar, packed
- 1 teaspoon grated lemon zest
- 1 teaspoon grated orange zest
- 1/4 cup heavy cream
- 2 lbs. pecans, coarsely chopped

1. Preheat oven to 350 degrees F.
2. For the crust, beat the butter and sugar with an electric mixer until light, approximately 3 minutes.
3. Add the eggs and vanilla. Mix well.
4. Sift together the flour, baking powder and salt. Mix the dry ingredients into the batter with the mixer on low speed until just combined.



5. Press the dough evenly into an ungreased 18 x 12 x 1-inch baking sheet, making an edge around the outside. It will be very sticky. Sprinkle the dough lightly with flour. Bake for 15 minutes until the crust is set but not browned. Allow to cool.
6. For the topping, combine the butter, honey, brown sugar, and zests in a large saucepan. Cook over low heat until the butter is melted, using a wooden spoon to stir.
7. Raise the heat and boil for 3 minutes.
8. Remove from the heat. Stir in the heavy cream and pecans. Pour over the crust, trying not to get the filling between the crust and the pan.
9. Bake for 25-30 minutes, until the filling is set. Remove from oven and allow to cool.
10. Wrap in plastic wrap and refrigerate until cold. Cut into bars and serve.
