# SWRE adds bill pay telephone service

SWRE has a special new telephone line to make it easier for members to pay their utility bill!

Co-op members who wish to pay by phone with a credit card, prepaid card, or debit card may now call a special number – **1-855-980-6821**.

When the call is answered, they will hear a prompt to enter their account number and payment information. It's easy, secure, and members can call day or night.

The payment will be processed and quickly posted to the proper account.

### Use traditional number for everything else

The traditional SWRE telephone number – **1-800-256-7973** – may still be used, as always, to contact SWRE personnel, report outages, or conduct business.

The new special automated telephone service gives members one additional option for making payments at any hour of the day, any day of the week.

### Other payment options

Of course, members may still make payments at the SWRE office in Tipton, by mail, online at [www.swre.com](http://www.swre.com), or utilizing the SWRE app for tablets and smart phones.

Payments are also accepted at designated banks throughout the service area. *Members must be aware,*

*however, that bank payments should be made at least 10 days before their bill's due date.* It often takes up to 10 days for payments made at banks to be received by SWRE.

Any account for which SWRE has not received payment by the due date is subject to disconnection – even if payment is in transit by mail from a bank. That is because the co-op has no way of knowing when payments have been given at a bank.

### Reconnecting Service

SWRE bills that are not received by the due date are subject to disconnection.

Services that are disconnected for lack of payment will NOT be reconnected until the bill is paid.

During traditional business hours, members may call the SWRE business office (1-800-256-7973) to arrange for services to be reinstated.

After business hours, the disconnected members may make payment at the new automated bill pay line (1-855-980-6821) using a credit card, prepaid card, or debit card. When payment has been made, they may call the other SWRE line to request that service be reinstated.

The fee for reinstatement of service for non-paid accounts is \$40 if the restoration is done during business hours and \$120 if the service is performed outside business hours.

This fee will be added to the following month's bill.

Joe then came home to serve as the Frederick Chamber of Commerce director for one year, until his next move to Southwest Rural Electric in 2006.

As Chamber director Joe invested his time and talents in his community. Judge Brad Benson, who served then as Frederick Chamber president, commented, "Joe has invested his life in Southwest Oklahoma. His insight in relating and communicating to people of all walks of life has been a wonder to

watch over the years I have known him. He is a student of our shared history, a voice of progress and concern, and a difference-maker in our communities. He provides wise counsel, and I'm honored to call him my friend."

According to Gary Tyler, superintendent of Great Plains Technology Center in Frederick, "Joe has volunteered his service to his community over the past 25 years more times than I can count. He has spearheaded bond elections and written more press releases than most newspaper men."

Joe has also served as president of the Frederick Chamber of Commerce and the Tillman County Historical Society. ## Call 811 before you dig

Spring is a time when many folks dig in their yard, plant trees or take on construction projects around their property.

There is no way for most people to know exactly where electric lines, cables, gas lines, or other dangers lie below the ground's surface. Digging without consideration can be

dangerous – and it's against the law in both Texas and Oklahoma.

In both states a call to 811 at least two working days before the dig will provide an opportunity for someone to come to the site and mark any underground lines.

The agency in Oklahoma that handles marking requests is OKIE811 (or "Call Okie").

In Texas, Texas811 is the agency.

Both agencies can be accessed by dialing 811 or through online requests at their websites.

Always... Call before you dig!

It's the law, and it could be the difference between a safe operation and disaster.

## Think before planting

If you plan to plant trees on your property this spring, keep them at a distance from overhead power lines.

It's important to remember that the seedling or small sapling that you plant today could be a huge tree within a few years. Trees that grow into power lines can cause outages, interfere with the flow of power, and present a safety hazard.

## What's Cookin' in the SWRE Kitchen

A great easy recipe from Texas Co-op Power's *The Best of Typically Texas Cookbook*

### Chicken Enchilada Casserole

- 1/2 cup chopped onion
- Butter
- 3-4 chicken breasts, boiled, boned and chopped
- 1 can (10.75 oz.) cream of chicken soup
- 1 can (10.75 oz.) cream of mushroom soup
- 1 small can (4 oz.) chopped mild green chilies
- 1 carton (8 oz.) sour cream
- Flour tortillas
- Cheddar cheese, grated

### Directions

1. Preheat oven to 350 degrees F.
2. Sauté onions in butter in a large skillet until clear. Add chicken, soups and chilies. Mix in sour cream.
3. Grease casserole dish. Line bottom with tortillas, then spread half the chicken mixture over the tortillas. Sprinkle with cheese. Repeat layer of tortillas, chicken mixture and cheese.
4. Bake until cheese melts.
