## ANNUAL MEETING HIGHLIGHTS

### DOUBLE DRIVE-THRU EVENT SETS ATTENDANCE RECORD

Coming from all over Southwest Rural Electric's Oklahoma and Texas service area, 405 SWRE memberships showed up for the 85<sup>th</sup> Annual Meeting on August 18, 2022. The double drive-thru event in Altus, Oklahoma and Vernon, Texas set a record for the highest number of memberships to ever register at an annual meeting. The second-highest attended meeting was held in Altus in 2019 with 404 registered memberships.

Far surpassing the 188 members needed to meet quorum, the membership voted by ballot to approve the 2019 Annual Meeting Minutes as written with 303 yay votes, 1 nay vote, and 101 members abstaining from the vote.

Registered members received a door prize bag full of SWRE goodies, a \$25 Energy Credit at registration and an entry into the prize drawing. The prize drawing was held the following week via live video broadcast on Facebook where co-op employees drew membership tickets for 21 \$50 District Energy Credits, 24 prizes donated by co-op vendors, and three grand prizes. **Carl Zipperle of Vernon** won the iPad Air, **Ronnie Richie of Vernon** won the Traeger

34 Pro Series Pellet Grill, and **Toby Kelley of Altus** won the 65-inch Vizio 4K Smart TV.

SWRE's charitable foundation, Operation Round Up (ORU), held an exclusive drawing for members who increased their monthly contribution to the foundation through ORU *Plus*. **Helen Paris from Altus** was the winner of the ORU *Plus* Drawing, taking home a Google Nest Thermostat and Trim Kit. The foundation raised \$65.50 more per month for ORU at the Annual Meeting. "Rounded up" change donated by generous SWRE members each month accumulates throughout the year and funds are distributed back to organizations and nonprofits in need in SWRE territory.

## PUMPKIN APPLE MUFFINS

### INGREDIENTS:

1 1/3 c. all-purpose flour	1 medium apple, peeled and grated
2/3 c. whole wheat flour	3 T. vegetable or canola oil
2 tsp. baking powder	1/2 c. agave or honey
1/2 tsp. baking soda	1 large egg
1/2 tsp. kosher or sea salt	1/2 c. milk of choice
1 tsp. ground cinnamon	1/2 c. pumpkin puree
1 1/2 tsp. pumpkin pie spice	

### DIRECTIONS:

1. Preheat oven to 350 degrees.
2. Combine the first 7 ingredients in a bowl and mix. Toss the grated apples in the dry mixture to coat.
3. In a separate bowl, whisk the remaining ingredients together.
4. Slowly add the flour mixture into the wet ingredients and stir until just combined.
5. Grease muffin tins or line them with muffin cups and fill each cup 3/4 full with the batter.
6. Bake for 20 minutes (12-14 minutes for regular size muffins) or until a toothpick comes out clean.
