Contest Rules & Application Instructions

The annual Energy Camp Contest is open to current 8th grade students living in or attending school in SWRE's service territory. This includes schools in Altus, Blair, Chillicothe, Crowell, Davidson, Electra, Frederick, Harrold, Navajo, Northside, Snyder, Tipton, and Vernon. Co-op membership is not required to enter the contest. *Children and grandchildren of SWRE employees and board members are not eligible to apply.*

Applications are open from January 1 to March 1 and must be submitted online at [SWRE.com/EnergyCamp](https://www.swre.com/energycamp) by March 1, 2024 at 11:59 p.m.

The application has one component:

- **Write an original, 300-500 word essay on this topic: What would life be like without electricity?**

What's on the online application?

1. Complete and upload the Applicant Information form.
2. Complete and upload the Contest Terms & Conditions form (must be signed by the student and parent/guardian).
3. Upload your essay.
4. Upload a headshot photo.

Applicants MUST be available to attend Energy Camp on May 28-31, 2024 @ Canyon Campgrounds in Hinton, Oklahoma. Students should not enter the contest if they will not attend camp.

Prizes:

Winners (one from Oklahoma and one from Texas): an all-expenses-paid trip to Energy Camp May 28-31, 2024

Finalists (up to eight finalists): receive \$50 cash prizes

ESSAY INSTRUCTIONS

PLEASE NAME YOUR FILE: EC24_LastName_FirstName_Essay

TOPIC: What would life be like without electricity?

Write an original 300-500 word essay, type-written on white 8.5x11 inch paper. The student's name should not appear on the essay. Essays will be scored by an independent judge on creativity, originality, accuracy, organization, grammatical correctness, style and content. The judge will select up to eight finalists including the top two essays (one from Oklahoma and one from Texas). All essays submitted become the property of SWRE and will not be returned.

***Energy Camp Cancellation & Reimbursement Policy:** Students selected and sponsored by Southwest Rural Electric Association, Inc. are expected to participate in required preparatory activities related to the Oklahoma Energy Camp and the full duration of the student program, including travel to and from Hinton, Oklahoma. The student experience has a program value of \$500 per participant. While cancellations are unfortunate, cancellations received/processed 30-days prior to the day of registration are appreciated and needed to allow cooperatives to find alternate student participants. Families of selected students who cancel less than 30-days prior to the day of registration, may be responsible for reimbursing the sponsoring cooperative up to 50% of the program value. No shows and families of selected students failing to notify Southwest Rural Electric Association, Inc. of nonparticipation may be held responsible for reimbursing 100% of the program value.
